



# Eligibility

### U.S. Women's Open Groove Specifications Acceptance

In Sectional Qualifying and in the Championship proper, the player's clubs must conform to the groove and punch mark specifications in the Rules of Golf effective from January 1, 2010. Note: Ping EYE2 clubs manufactured prior to March 31, 1990 may not be used during Sectional Qualifying and the Championship proper. The Condition of Competition is available for review on the entry application. By filing this entry, the player acknowledges that this Condition of Competition is in effect and the player will comply with this condition.
