If the player is exempt, please select an exemption category and click Continue at the bottom of the exemptions list. If the player is not eligible for exemption from qualifying, please click Not Exempt to select your Qualifying site.



Players in the following categories will be eligible for exemption in the 2022 Championship only. The USGA reserves the right to revise any of the exemption categories. Exemption under categories reserved for amateurs will be granted only to players who are currently amateurs, unless otherwise indicated. An amateur who is exempt into the Championship proper through a category reserved for amateurs becomes ineligible if she becomes a professional before beginning play or during the play of the Championship, unless otherwise indicated. Exempt players who wish to participate in the Championship must file an entry, except those players for whom blank entries are filed as noted below.

Please note that players who "no card" are subject to receive a letter from the USGA under the same guidelines as those who do not return a score within 12 strokes of the Course Rating.
