**All fully and locally exempt players must file an entry at [champ-admin.usga.org](http://champ-admin.usga.org) by 5 p.m. EDT on April 10 to confirm their position in the Championship field.** Please contact Brent Paladino at [bpaladino@usga.org](mailto:bpaladino@usga.org) with any questions.

NOTE: The first OWGR ranking category date will be finalized on Monday, May 20 and the second OWGR ranking category date will be finalized on Monday, June 10. The Top 60 point leaders and ties in the OWGR as of May 20, 2024 or June 10, 2024 will become exempt (if not previously exempt). Additionally, the top five players in the 2022-23 FedExCup standings as of May 20, 2024 who are not otherwise exempt or in the top 60 OWGR as of May 20, 2024 will earn an exemption.

At the Championship proper only, the USGA will test a random sample of player's driver heads, that are intended for play in the Championship, for conformance to the Characteristic Time (CT) limit and maximum allowable club-length limit (Model Local Rule G-10). [Click here for more information](#)
